- 5. Mayor Thomas has been unable to reach the Highway Dept. regarding the "No parking" sign at the store.

New business:

- 1. Mr. Fitzsimmons informed the Council that he was able to acquire, at a sale, tow shovels, one spade, one axe, one square and one rake for the Park.
- 2. Alderman Durland moved that Clerk Treasurer carry out all receipts and disbursement transactions through February, 1985. Alderman Benge seconded the motion. Vote carried unanimously.

The new hours for the Post Office was mentioned and the route number will be changed from Rt. 2 to Rt. 3; box numbers at the post office will remain the same. The Postmaster has asked for estimate of anticipated growth for next 12 to 22 years.

Mr. Fitzsimmons mentioned that the Fire Department held special meeting on Saturday, Feb. 2nd, for election of officers, and it was voted to hold future meetings on the last Saturday of each month at 2:00 P.M.

Alderman Reitz made motion to pay current bills, seconded by Lorena Durland, carried unanimously.

Mayor Thomas reported that he and Alderman Rutter had attended the Freedom of Information lunch on Jan. 25th.

Letter from W. H. Taylor, attorney for Fuss Boillot. was read and also letter from City Attorney Maberry, re blacktopping on entrances to city streets. Copies of city checks and personal checks will be forwarded to Attorney Maberry in Florida.

 - 3. Fitzsimmons and Johnson have completed the plumbing.
- 4. Six more tables are needed for the Park, in order that the six heavy tables can be brought up to the Community/Fire Station park area.
 - 5. The bird houses are up, but one was lost in the flooding.
- 6. Mr. Fitzsimmons requested that a bell from an old phone is needed to install inside the Park booth, if anyone has one to donate.
- 7. Due to water levels, the Park must be addressed as two separate areas--Upper and Lower--especially for electrical purposes.
- 8. Additional gravel is badly needed throughout the Park and Attendants' trailer site.
 - 9. There will be a Park Committee meeting tomorrow Tuesday

SPECIAL MEETING of the Council of the incorporated town of Beaver, Arkansas, was called by Mayor Thomas on April 4, 1985.

Mayor Thomas called the meeting to order at 9:00 A.M. Present were Aldermen Baldridge, Rutter, Reitz and Clerk Fitzsimmons. Absent: Alderman Benge.

Also present: John Ratliff and Jim Fitzsimmons (park board).

Park Chairman, John Ratliff, informed the council that he had reason to believe the Park fee for camping should be raised \$1.00. He stated that he had checked other Parks in the area and found our Park was much lower than the others. In view of the fact that the Park insurance was raised \$400.00, motion was made by Alderman Baldridge to raise the camping fee from \$5.00 to \$6.00. Motion seconded by Rutter; all voted in favor; carried unanimously.

It was suggested that the Park remain open after the closing (official) on November 1, 1985; and as before, the attendant will receive any and all receipts (except electric, which he will turn into the City Clerk) as reimbursement for keeping Park and restrooms clean.

Mayor Thomas read letter from the Berryville Park Committee regarding the sale of the County Fairgrounds for purpose of industrial use, and asking Beaver council for its support. The Council agreed to back the Berryville committee.

Mr. and Mrs. Fitzsimmons and Mr. and Mrs. Renfro spent Wednesday at Branson, Table Rock Corps, for schooling on a survey of Parks to be taken this summer and Fall.

Alderman Reitz will look into some means of relief for keeping leaves raked in the Park by means of equipment.

John Ratliff will look into advertising in the Flashlight for the Park.

Motion made, seconded and carried to adjourn.

Mayor Thomas read a letter from the State of Arkansas Legislative Joint Auditing Committee in reference to their filing the #3 Year Audit Report (Years '81, '82 and '83) of the town of Beaver.

Also read was a letter from the Arkansas Municipal League regarding Act 866 dealing with the Workmens Compensation Coverage. The Mayor stated that he will file the report as pertains to Beaver.

On the same subject, a letter was read from the Arkansas Municipal League informing the Council that there will be a meeting for incorporated towns dealing with this same issue, to be held in Little Rock on May 15, 1985. Mayor Thomas stated that he will contact the League inquiring as to the possibility of acquiring a kit from the Little Rock meeting.

After much discussion as to the value of the Arkansas Municipal League, Alderman Durland moved that the town of Beaver join said League, and that the Treasurer send the fee of \$162.50. The motion was seconded by Alderman Benge; and motion carried unanimously.

A letter was read from Bobby Odom, Fayetteville attorney, regarding the progress of the lawsuit against Sugg Oil's responsibility for gasoline in some of the Beaver wells. Also, a letter from Pollution Control and Ecology regarding their meeting in Little Rock with Sugg Oil, was read.

Mayor Thomas read from the Municipal League Handbook, Sec. 5-4.11 titled "Referendum Ordinance." (Ordinance 1.00).

Alderman Reitz: "I move we, the Council of Beaver, Arkansas, adopt a Referendum Ordinance as Ordinance 1.00; an Ordinance fixing the time for filing of a Referendum Petition provided for by the Amendment No. 7 of the Constitution of the State of Arkansas."

Mayor Thomas then appointed a Zoning and Planning Commission consisting of five (5) members:


- 1. John Ratliff

The next order of business was the presentation of Ordinance 1.02, a Zoning and Planning Ordinance, by the Chairman of the Zoning and Planning Commission, John Ratliff.

Before the reading of the Ordinance by Ratliff, Alderman Baldridge moved that the Council accept this reading as the first reading of Ordinance 1.02, A Zoning and Planning Ordinance. Motion seconded by Alderman Benge; Baldridge, Rutter, Benge, Durland and Clerk Fitzsimmons all voted Aye; no Nay votes, motion carried unanimously.

John Ratliff then read Ordinance 1.02, "A Zoning and Planning Ordinance" in its entirety.

Mayor Thomas asked for discussion from the Council and/or the citizens present. The Mayor then recognized Jamie Harris, who stated that she did not fully understand Secion 4. The Mayor addressed the question to Mr. Ratliff. Mr. Ratliff stated that the answer was, in reality, in Section 6. Upon explanation, Ms. Harris stated that she had no further objections.

The Mayor then recognized Alderman Benge, who had questions regarding permit fees. Ratliff stated there would be no Permit Fees—the only building fees would be fees charged by the State Inspectors. Benge also objected to the Commission having final say. Ratliff noted that an appeal can be made to the Council at any time, by anyone.

The Mayor then recognized Reta Marty, who raised an objection to Secion 5 (F)—the exclusion of trailers as permanent dwellings (single wide).

After further discussion, the Council found it could not accept Ordinance 1.02 as it was presented, and returned it to the Commission for the recommended revisions.

Mr. Ratliff stated that the Commission will consider changes in Section 5, the sections that was questioned.

With no further business, motion was made, seconded and carried to adjourn.

ORDINANCE 1.02

"THE ZONING AND PLANNING COMISSION IS AN ORDINANCE TO ESTABLISH A PLAN FOR OXDERLY GROWTH WITHIN THE CITY VINITS OF THE TOWN OF BEAVER, BEAVER, ALKANSAS. O REGULATE THE LOCATION, DESTAN, CONSTRUCTION, ALTERA-TION, INSTALLATION AND MAINTENANCE OF INDIVIDUAL AWELIINGS, BUSINESS ESTABLISH-MENTS OR ADDITIONS THERETO; TO DETERMINE AND ESTABLISH GEOGRAPHICAL AREAS FOR COMMERCIAL, RESIDENTIAL AND AGRICULTURE AUTHORIZING THE ISSUANCE OF BUILDING PEIN TS: TO ESTABLISH PROCEDURES FOR COMPTIANCE OF BUILDING CODES; AND TO ESTABLISH OCEDURES FOR COMPLIANCE OF SANITATION, HEALTH AND SAFETY CODES."

SECTION 1. TITLE. This Ordinance shall be known as the Zoning and Planning Ordinance.

SECTION 2. FINDINGS AND POLICY, The Commission hereby finds and determines that this Ordinance is fair and equitable to all citizens of the Town of Beaver and that the policies and procedures are not intended to cause a hardship for any citizen but is enacted to insure an orderly growth within the Community for the observance of building codes, geographical areas, sanitation, health and safety of all concerned. The Commission further determines that all building, zoning, septic and water systems will be erected or established in accordance with County, State and Federal laws and that proper authority will be required prior to approval by this Commission.

SECTION 3. DEFINITIONS.

- a. "Homeowner" means a person who ownes and occupies a building as his home.
- b. "Landowner" means a person who ownes land inside the City Limits of the Town of Beaver.
- c. "Zoning and Planning Commission" means a Commission duly founded by Ordinance by the Town Council of the Town of Beaver.
- d. "Builder" means any person, firm, corporation, association, municipality, or government agency, who for compensation constructs, installs, alters or repairs individual, partnership, or corporate buildings or lands for others.
- e. "Town Council" means an authoritative group of elected persons who have final authority over requests submitted to the Commission.

SECTION 4. SCOPE. No person shall construct or alter their building, home or lands in the Town of Beaver contray to the provisions set forth in this Ordinance and applicable County, State and Federal rules and regulations.

SECTION 5. AUTHORITY TO ADOPT RULES, REGULATIONS AND PROCEDURES. The Commission will have final authority to approve or disapprove any and all requests as to location, design, construction, installation or zoning that has been properly submitted. It will be the responsibility of the "Commission" to review all requests to insure that the "Builder" or "Landowner" has met all the required rules and regulations.

- a. The "Commission" will have final authority to enforce the provisions set forth in this Ordinance.
 - b. The "Commission" will issue building permits.

SECTION 6. ZONING AND PLANNING CODES. The construction, installation or alteration of any structure larger than ten (10) by twelve (12) feet will require the approval of at least three fifths (3/5) of the five (5) member "Commission". Complete plans must accompany each request, along with an attached permit from the County Health Department for septic service (where applicable) at the location or lot.

- a. EXISTING STRUCTURES. The grandfather clause shall pertain only to existing permanent structures. In the event that property or present structures are sold or moved the protection under the grandfather clause will no longer apply.
- b. LOT SIZE. The lot size will vary to meet State and County Health Department codes and will meet with septic requirements and codes.

- c. BUILDING SIZE AND EXTERIOR FINISH. A minimum of twelve hundred (1200) square feet, under roof, with a minimum of seven hundred fifty (750) square feet of living space is required. The exterior will have a finished type siding installed. No insulation board or building paper will be left exposed. Exterior will be painted or stained according to the type of finish installed. No structure will be constructed taller than two (2) stories.
- d. OCCUPANCY AND COMPLETION. The structure will not be occupied until water, sewer and electricity is connected and the structure is at least seventy five (75) percent complete. The structure must be completed in not more than twelve (12) months from date of issuance of permit.
 - e. LOT LINES AND EASEMENTS.
- (1). Front easements on main roads and streets will be no closer than forty (40) feet from the center of the road or street.
- (2). Side easements on lots or property will be no closer than ten (10) feet.
- (3). Rear easements on lots or property will be no closer than thirty (30) feet.
- f. TRAILERS, MOTOR HOMES AND MOBILE HOMES. Travel trailers, motor homes and mobile homes will not be used as permanent or vacation residence, however, they may be used as temporary living quarters while the permanent residence is under construction. Temporary quarters will not exceed a period of one (1) year. Mobile homes will be removed from the property upon completion of the permanent residence. Travel trailers and motor homes will be vacated upon completion of the permanent residence.
- g. MOBILE HOME PARK. The Mobile Home Park presently located in the Town of Beaver, consisting of eleven (11) hook-ups or sites, is designated a Mobile Home Park and will be limited to the present number of hook-ups or sites.

- h. ELECTRICAL AND INSIDE PLUMBING. Electrical and inside plumbing will meet present County, State and National Electrical and Plumbing Codes and will be inspected at intervals as set forth under Section Seven "Inspections".
- i. EXCAVATION AND WATER SHED. Earth, rock, gravel, etc., will not be moved as to drain on other property or disturb the natural water shed.
- j. CULVERT AND DITCH DRAINAGE. Culverts of not less than twelve (12) inches in diameter will be installed when the property connects to County or State roads, is a designated city or private street, except at a natural crown.

SECTION 7. INSPECTIONS.

a. During the construction of any structure, the Commission or designated representative must make progress inspections at certain key points of such construction. The Commission or his representative will check the applicant's construction within twenty-four (24) hours of the requested inspection, Monday through Friday. It is the duty of the applicant or his contractor to advise the Commission when the structure is ready for inspection on the following points:

^{*} A water test is required by 14.8.1 of the Arkansas State Plumbing code.

b. If the Commission or his representative is not contacted to conduct an inspection at the construction points listed previously, he will require the owner or contractor to remove or redo whatever work is required to make a proper inspection.

SECTION 8. CONSTRUCTION GUIDES.

- a. All construction must meet the standards described in the current editions of the following documents:
- (1) Southern Building Code International Conference Building Officials;
- (2) Arkansas State Plumbing Code Arkansas State Health Department;
- (3) National Electrical Code National Fire Protection Association:
- (4) Southern Building Code Congress Mechanical Code.
