

PUBLIC HEARING ON PROPOSED 1987 BUDGET - January 5, 1987

The Council met at 1:30 on January 5, 1986 and the Mayor called the meeting to order. Five aldermen answered roll call: Baldridge, Benge, Reitz, Dorn and Rutter. Five members of the community also were in attendance.

After the reading of the proposed budget for 1987, the Mayor asked for any discussion and/or questions from the floor, and also requested any additions or corrections from the Council.

Alderman Baldridge moved that the budget be presented as written to the Council for vote at the regular council meeting following the hearing. Motion seconded by Alderman Benge, vote carried unanimously.

Motion was then made and seconded to adjourn at 1:40 P.M.

The Council of the incorporated town of Beaver, Arkansas, met at the Community Building for the January regular meeting, which was postponed from January 3 to January 5 because of the Dick Achord funeral. Notices of postponement were posted and also announced on the radio.

The Mayor called the meeting to order at 2:00 P.M. and five Aldermen answered roll call: Baldridge, Reitz, Benge, Dorn and Rutter. A quorum was present.

Minutes read and approved as corrected.

The Mayor reported that the So. Bldg. Code Congress International has been received.

Jim Fitzsimmons reported that the Park Committee had a meeting on January 1, 1987 and the following projects are planned:

1. Finish Barbeque

2. Painting pavilion and washrooms

3. Additional gravel

4. Two leaf blowers to be determined as to price and then presented to Council for their perusal.

Alderman Reitz reported that the Zoning and Planning Commission met before lunch and that they are working on an Amendment to Ordinance 1.02 which will be presented to the Council at the next meeting.

Mayor Ratliff reported that Russell Koester has agreed to serve on the Street Committee with Chairman Homer Rutter, and that he had asked several others to serve but they refused. He will contact another member of the community to serve as third member of the committee. Chairman Rutter will investigate cost of a seal coat for the street in question, and will also get bids for hot mix.

Mayor Ratliff again welcomed Helen Dorn as a new Council member and expressed his and the Council's appreciation.

Mayor explained the need for an Ordinance "providing for and adopting an ordinance beginning on January 1, 1987 and ending on December 31, 1987 for the town of Beaver, Arkansas to appropriate money for each and every item of expenditure therein provided for, declaring an emergency to exist and other purposes." The Clerk read Ordinance 2.01 and the Mayor requested discussion. Then Alderman Baldridge made a motion that this be the first reading of Ordinance 2.01; motion seconded by Alderman Rutter. The Mayor repeated the motion and asked, "How do you vote?"

Clerk called for voice vote: Reitz: Aye

Rutter: Aye
Baldridge: Aye
Benge: Aye
Dorn: Aye.

The Mayor called for discussion.

The Mayor asked for voice vote on first reading. All voted Aye.
Alderman Reitz made motion to suspend the rules and that Ordinance
2.01 be placed on second reading. Motion seconded by Alderman Rutter,
carried unanimously.

The Mayor repeated the motion and asked, "How do youvote?" The Clerk called for voice vote. All aldermen voted Aye.

The Clerk read Ordinance 2.01 for Second Reading. She then asked for voice vote. Each alderman voted "Aye."

Alderman Dorn made a motion to further suspend the rules and that Ordinance 2.01 be placed on Third and Final reading.

Motion seconded by Alderman Benge. Motion carried unanimously. The Mayor repeated the Motion and a ded, "How do you vote?"

The Clerk called for voice vote and each Alderman voted "Aye."

The Clerk read Ordinance 2.01 for Third and Final Reading. The Mayor asked for discussion. Then asked, "How do you vote on the Third and Final reading of Ordinance 2.01; shall this ordinance pass?"

The Clerk asked for voice vote and each Alderman voted "Aye."
The Mayor then stated, "Ordinance 2.01 has passed unanimously
on first, second and third reading."

The Budget for the year 1987 was read by the Mayor in detail. Alderman Benge made motion that the Budget be approved as read; seconded by Alderman Rutter. Each alderman voted "Aye" to voice vote requested by Clerk. Motion carried.

The Mayor announced that the weight limits for the bridge are now installed at Highways 23N and 187 and also at 62W. He said this will alleviate some of the traffic, but asked cooperation of the community in reported overloads, etc.

The insurance policy for the Marshal was discussed and the Mayor asked the Council to study the policy further as to further coverage and for their final decision.

The Mayor, Clerk and Aldermen were sworn in on January 2, 1987 by the County Clerk, Steve Swafford.

The Council of the Incorporated town of Beaver, Arkansas, met at the Community Building for the February meeting on February 7, 1987 at 2:00 P.M.

The Mayor called the meeting to order and five aldermen answered roll call: Baldridge, Benge, Rutter, Reitz and Dorn. A quorum was present.

Minutes of the last meeting were approved as read.

Mayor Ratliff reported on correspondence to the Corps of Engineers regarding renewal of contract for the Park and insurance problems. Also a letter from the insurance agent noting they have not yet found insurance coverage for us. A letter from Richard Groves, Corps Resident Engineer, was read, giving dates for the Spring Cleanup as April 25th through May 2nd.

Mayor Ratliff suggested that Beaver have the usual cleanup of Park on the last weekend of March or first weekend of April, and the road and Lake cleanup with Missouri Table Rock Beautification dates.

Park Commission Chairman, Jim Fitzsimmons, left word that the Hamms are returning as Park Attendants, and will be here before April 1st.

Zoning and Planning Commission Chairman, Ed Reitz, stated his committee have completed an Amendment to Ordinance 1.02 (to be Ordinance 1.04), which is ready for council approval.

Street Commission Chairman, Homer Rutter, stated his committee is still comparing prices for Hot Mix and Sealcote. The Mayor reported that Bob Marty has accepted an appointment to the Street Commission committee.

NEW BUSINESS: Mayor Ratliff requested reading of Ordinance 2.02, AN ORDINANCE ESTABLISHING PROCEDURAL RULES FOR COUNCIL MEETING OF TOWN OF BEAVER, ARKANSAS, INCLUDING PROCEDURE FOR CALLING SPECIAL COUNCIL MEETINGS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

The Clerk read the Ordinance 2.02 in its entirety.

Alderman Benge moved that this be the FIRST READING of Ordinance 2.02. Motion seconded by Alderman Rutter. The Mayor repeated the Motion and called for discussion. After discussion by Council members, the Mayor asked, "How do you vote on first reading?" The clerk asked for voice vote. Aldermen Reitz, Rutter, Benge, Baldridge and Dorn each responded, "Aye."

Alderman Reitz moved to suspend rules and that Ordinance 2.02 be placed on SECOND READING. Motion seconded by Alderman Baldridge. The Mayor repeated the motion and the Clerk called for voice vote. Alderman Reitz, Rutter, Baldridge, Benge and Dorn each responded, "Aye." Clerk read Ord. 2.02 for the second reading.

Alderman Baldridge moved to further suspend the rules and that Ordianance 2.02 be placed on THIRD and FINAL READING. Motion seconded by Alderman Rutter. The Mayor repeated the motion and the Clerk called for voice vote to further suspend the rules and that Ordinance 2.02 be read for third and final time. Aldermen Reitz, Rutter, Benge, Baldridge and Dorn each responded, "Aye." Clerk read Ordinance 2.02 for third reading.

The Mayor repeated the Motion for voice vote, asking "Shall this Ordinance

The Council of the incorporated town of Beaver, Arkansas met at the Community Building on March 7, 1987.

The Mayor called the meeting to order at 2:00 P.M.; four aldermen answered Roll Call: Reitz, Rutter, Dorn and Baldridge. Alderman Benge was absent. A quorum was present.

Minutes of the last meeting were read and approved.

Mayor Ratliff reported that the Financial Statement was printed in the February 19th TIMES ECHO, and was posted at the Community Building bulletin board.

Mayor Ratliff read letters from Richard Groves, Resident Corps Engineer, regarding to the Table Rock Lake Cleanup, which will be April 25th through May 2nd. Also letter from Brown, Clark Insurance Company regarding insurance on the Park. The Mayor will renew as soon as the Park Contract is officially renewed. The Park management Plan for 1987 has been accepted.

The Park Committee reported that the Barbeque at the Pavilion has been completed.

Zoning and Planning Chairman, Ed Reitz, reported that a Building Permit has been issued to T. R. Thomas.

Street Commission Chairman, Homer Rutter, reported he has one bid of \$7100.00 for 2" blacktop for street in Lazy L Subdivision. He will be looking for additional bids. Mayor Ratliff mentioned that he had been contacted by Consolidated Asphalt in Joplin, and that they will submit bid.

The Beaver Beautification and Park Cleanup week will be March 23rd through March 28th. Once again members of the community are urged to call if help is needed for large items for dumpster. Volunteer workers will clean up Park on March 27th and 28th, and lunch will be provided at the Park on Saturday, March 28th by the ladies auxilliary.

The Clerk, Flo Fitzsimmons, will have large calendar with dates of various activities posted in the bulletin board outside the community building.

New Business: Mayor Ratliff explained in detail an ordinance suggested by the Arkansas Municipal League that is necessary for purchases of supplies and services exceeding \$5,000.00. Also for supplies and services under \$5,000 to be delegated to local persons if possible. This will be <u>Ordinance 2.03</u>, and after FIRST READING and discussion, all aldermen present voted Aye. The motion for acceptance of Ordinance 2.03 was made by Alderman Dorn, seconded by Homer Rutter.

A town seal will be designed and presented to the Council for approval. Alderman Dorn will meet with Tommy Thomas in that regard.

pass?" Each of the five aldermen voted, "AYE." The Mayor then stated: "Ordinance 2.02 has passed on all THREE READINGS, and is, as of this date, in full effect."

Alderman Reitz, Chairman of the Zoning and Planning Commission, had stated earlier in the meeting that the committee had prepared an amendment to Ordinance 1.02, to be called Ordinance 1.04, and at this time read the Ordinance amendment and placed it before the council for approval. He read as follows:

AN ORDINANCE AMENDING THE BEAVER ZONING AND PLANNING ORDINANCE 1.02, SECTION 6, CREATING A PENALTY CLAUSE AND AN EMERGENCY CLAUSE.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF BEAVER ARKANSAS: THAT SECTION 6, ZONING AND PLANNING ORDINANCE OF BEAVER, ARKANSAS, IS HEREBY AMENDED BY ADDING SUB-PARAGRAPH k (Enforcement of Ordinance), and SUB-PARAGRAPH 1 (EMERGENCY), which shall read as follows:

SECTION 6.

k. Enforcement of Ordinance. Any person or persons offending against or violating the provisions of Ordinance 1.02 shall be deemed guilty of a misdeameanor and upon conviction shall be fined not more than \$25.00 each day for each offense or violation that occurs. Each day said offense or violation occurs shall constitute a separate offense.

1. Emergency. Being aware of the necessity for an Ordinance to establish a plan for orderly growth within the Town of Beaver, that would include a penalty for non-compliance and being necessary for the preservation of the public peace, health, safety and welfare, an emergency is hereby declared and this ordinance shall be in full force and effect from and after its passage.

Alderman Dorn moved that the Council accept the Amendment to Ordinance 1.02 as written and read. Motion seconded by Alderman Benge. A voice vote of "Aye" was unanimous by all five aldermen.

The Mayor asked the Clerk to read Ordinance 1.04. Alderman Baldridge moved that this be the FIRST READING of ORDINANCE 1.04, motion seconded by Alderman Rutter.

Mayor Ratliff repeated the motion and asked for any discussion. The Mayor called for voice vote on first reading of Ordinance 1.04, and each of the five aldermen voted, "Aye."

Mayor Ratliff then stated that Ordinance 1.04 has passed the FIRST READING this 7th day of February, 1987, and the second reading will be at the March council meeting.

Meeting adjourned.

The Council of the incorporated town of Beaver, Arkansas met at the Community Building on April 11, 1987, for the regular monthly meeting.

Mayor Ratliff called the meeting to order and all five aldermen answered roll call: Baldridge, Reitz, Rutter, Benge and Dorn. A quorum was present.

Minutes of the March meeting were approved as read.

CORREPONDENCE: Mayor Ratliff read letters from the Corps of Engineers regarding the Cleanup April 27th through May 2nd; also letter from the Corps regarding the Lease and phone call concerning the insurance. He reported on phone call from the National Sheriff's Association regarding insurance coverage for the Sheriff and the town.

Ed Reitz, Zoning and Planning Commission Chairman, reported that a building permit had been issued to the Sybrandts for an addition to a garage.

Jim Fitzsimmons, Park Chairman, reported the new Barbeque is being put to good use. Also that the Park Cleanup was a success, and he thanked all that helped. He mentioned that the trees have been planted and that the pads have been raked and spread with gravel, and a new culvert installed for pads, 38-39. A roof has been put over the telephone. Also an ad in the Eureka and North Arkansas Journal has been approved by the Park Committee for six months, bi-monthly @ \$40.00 per month.

Alderman Baldridge moved that the Council accept the Park Committee's recommendation for a bi-monthly ad in the Journal @ \$40.00 per month. Motion seconded by Dorn. Carried unanimously.

Alderman Benge suggested that a survey be taken to determine if the ad is actually a benefit to the Park.

Homer Rutter, Street Commissioner, reported that he is waiting for the completion of ordinance before any monies can be spent on improvement of city streets.

Helen Dorn reported that To Ro Thomas had made a rough draft of seal for the Town of Beaver. After discussion and examination, Alderman Reitz moved that the Council accept the drawing as presented to be followed. Motion seconded by Alderman Benge and carried unanimously. Mayor Ratliff thanked Helen and Tom.

Ordinance 1.04 (an amendment to Zoning and Planning Ordinance 1.02) was discussed. Alderman Dorn made motion that Ordinance 1.04 be placed on third and final reading. This amendment to Ord. 1.02, Section 6, creates a penalty clause and an emergency clause/Motion seconded by Alderman Rutter, and all five aldermen voted Aye. Motion carried unanimously. Mayor Ratliff announced the passing of Ord. 1.04 on its third and final reading on this 11th day of April 1987, and announced this ordinance is now in force.

Minutes, April 11, 1987 Page 2

Alderman Baldridge moved that Ordinance 2.03 (Business Ordinance, Purchasing Law) be brought before the Council for the second reading. Seconded by Alderman Benge. The Mayor then repeated the motion and read the Ordinance. All five aldermen voted Aye. Motion carried unanimously.

The Mayor reminded those present of the Lake Cleanup April 25th through May 2nd, and mentioned that picnic and prizes will be at the Fire Strion on Saturday, May 2nd at 12 noon for those participating. Council meeting will follow the picnic.

The Rummage Sale for the Fire Dept. will be May 8th and 9th, and sale items can be brought to the Fire Station after the Hootenanny on April 26th, and workers will be at the Fire Station beginning Monday, April 27th, all week.

Mayor Ratliff noted that the Marshall will be insured through the County by the town. Insurance for all public officials, elected and appointed is being investigated. Alderman Baldridge suggested that more information is needed before final council decision on liability protection.

Mayor Ratliff read Ordinance 4.01, Standards and Requirements for Public and Private Roads to be designated as town streets. Alderman Dorn stated that she could not move to accept this ordinance but would make a motion to consider it after more discussion and comments by all interested parties. Motion seconded by Alderman Benge, carried unanimously. Copies of this ordinance will be given to all council members and a special meeting will be called. Alderman Benge said that no town road would meet the requirements as set out in the ordinance, and the Mayor mentioned that there are waivers.

Mr. Thomas requested that he be allowed to address the Council on this subject. He stated that there are no other houses on the road in question other than the one he is building. However, he anticipates there will be future development. He said he is not asking for any favors; that the road has been there for 10 years and that it has a 30' road easement. He noted that the Lazy L road has been maintained by Homer Rutter except for gravel spread by the town a few years ago. He suggested that the Council use Street Fund money, augmented by the general fund, to improve roads in the town.

The Mayor stated that he would take all suggestions under consideration, and if something can be done legally, he will take it before the Council.

Jamie Harris of the Stone castle Inn and Court Jester Restaurant addressed the Council regarding serving wine and beer in the restaurant with meals. She requested the Beaver Council have an ordinance similar to the Eureka Springs ordinance for restaurants and motels. Mayor Ratliff and the Council agreed that they will need more information and discussion before a decision can be made.

The Mayor expressed his thanks to all that participated in the Park Cleanup, and also thanked the Town of Beaver on behalf of his family for the flowers sent to his father's funeral. He said he will plant them in his yard and remember always.

There being no further business, motion was made and carried to adjourn.

The Council of the incorporated town of Beaver, Arkansas, met on May 2, 1987 at the community building for the regular monthly meeting.

Mayor Ratliff called the meeting to order at 2:00 P.M., and four aldermen answered roll call: Reitz, Rutter, Baldridge and Benge. Absent: Helen Dorn. A quorum was present.

Minutes of the April meeting were read and approved.

Correspondence: The Mayor read a letter written to the Corps of Engineers in reference to the railroad lease. He also read letter concerning water supplies and services for testing area water.

Unfinished business: Mayor Ratliff reported that he had contacted the ABC in reference to the serving of beer and wine at the Stonecastle Inn; and that he was told that no license could be issued to a town of less than 7500 people.

Alderman Benge moved that Ordinance 2.03 be put on third and final reading. Vote carried unanimously.

Mayor Ratliff read Ord. 2.03 (Business ordinance, Purchasing Law) and repeated motion. Vote carried unanimously. Ordinance 2.03 is now in force as of May 2, 1987.

Alderman Benge made motion that Ordinance 4.01 (Standards and Requirements for Public and Private roads) be accepted as corrected by council and road commission, and placed on first reading. Motion seconded by Alderman Reitz. Aye vote was unanimous. The Mayor read Ordinance 4.01 and repeated motion. All four alderman voted Aye, and motion carried.

Alderman Reitz then moved that the rules be suspended and that Ordinance 4.01 be placed on second reading. Motion seconded by Alderman Baldridge. Aye vote unanimous and motion carried. Mayor Ratliff read Ordinance 4.01 and again repeated the motion. All four aldermen voted aye; motion carried.

Alderman Rutter moved to further suspend the rules and place Ordinance 4.01 on third and final reading. Motion seconded by Alderman Reitze, vote unanimous and carried. Ordinance 4.01 was read again by the Mayor and motion repeated. All voted Aye, and motion carried for third and final reading, and is now in force.

Tom Thomas volunteered to do the art work for the town seal, after which the Mayor will take it to the company to be made at a cost somewhere in the neighborhood of \$200.00. Alderman Reitz moved that the Council order the town seal; motion seconded by Alderman Benge; carried unanimously.

Alderman Benge made motion that Council accept the bid of \$680.00 for insurance to cover all elected and appointed town officials. Motion seconded by Alderman Reitz, carried unanimously.

Motion made, seconded and carried to adjourn.

A special meeting of the incorporated town of Beaver, AR was called on May 18, 1987, after due notice to newspaper, for the purpose of discussion regarding the Park Lease, the railroad and the recent break-ins at the Community Building and Park.

Mayor Ratliff called the meeting to order at 7:30 P.M. All five aldermen answered roll call: Baldridge, Dorn, Benge, Reitz and Rutter. The Mayor asked Georgene Thomas to take minutes due to absence of Clerk Fitzsimmons, who is out of town.

The Mayor read letter of May 5, 1987 from Corps of Engineers with attached draft of Supplemental Agreement, extending term of Park Lease to May 14, 1992. The letter noted that State subdivisions in Arkansas are immune to tort liability, which may solve the insurance problem.

Mayor Ratliff said that he had subsequently talked with Charles Burcham by phone, and explained that it was the desire of the town to have the lease extended to 50 years because of planned improvements for the Park, etc.; and that he will return the draft to the Corps for revision.

Regarding the railroad, the Mayor explained in detail the violations committed by the crew working for Jerry Mitchell, the man who bought the railroad from Yeat Younger; and of his frustrations encountered in his attempts to stop the men from dismantling the railroad bridge, as well as trying to prevent them from taking the dangerous and overweight loads across the Beaver bridge. He contactedRRichard Groves in Branson on Saturday, May 16th, the Sheriff, the Marshal and the Highway Patrol. The truckers had no permits to carry oversize loads on the highway and were fined \$1800 when the State Hwy. Patrol caught them when they moved the locomative. Pictures were taken by Mayor Ratliff, Linda Durland and the Corps Ranger. The safety of the bridge is of great concern to the community and some damage has been done to the beams and boards by these men. Suggestions were made to write to the Arkansas Senators and Congressmen by all interested parties.

Lorena Durland mentioned that the first train went through Beaver in 1882, and that the railroad has great historic value to the community. Since Reat Younger's lease with the corps of Engineers reads that the property is to be left in as good or better condition, the removal of the timbers and stringers are clearly an intentional violation.

The Mayor reported that the Bob Marty family had found a case of pop behind the Fire House, evidently left by the vandals the night of May 8th. The Post Office and Park break-ins were discussed, and suggestions were made as to remedies for Park security. The Mayor said proper authorities were notified and the occurrences are under investigation.

Meeting adjourned at 8:45 P.M.

The Council of the incorporated town of Beaver, Arkansas met on June 5, 1987, for the regular monthly meeting.

Mayor Ratliff called the meeting to order and three Aldermen answered Roll Call: Rutter, Benge and Baldridge. Absent: Reitz and Dorn. A quorum was present.

Minutes of the regular May meeting and special May meeting on May 18, 1987, were approved as read.

CORRESPONDENCE: Mayor Ratliff read letters in regard to the Beaver Railroad bridge to Mr. Burcham and Mr. Groves of the Corps of Engineers.

COMMITTEE REPORTS: Park Commission Chairman, Jim Fitzsimmons, reported that a new lock has been installed on the Attendance Booth. The Park refuse collection fee has increased from \$75.00 to \$100.00 monthly.

There will be no town or Park sponsored fireworks this year, but there will be a designated area on the beach for all campers and residents on the 4th of July from 8:00 P.M. to 10:00 P.M. only.

UNFINISHED BUSINESS: The Mayor mentioned that he will continue to correspond with the Corps regarding the Park Lease.

There is no further word on the progress of the Town Seal; and still no word on the outcome of the Beaver breakins.

NEW BUSINESS: After much discussion, Alderman Bladridge moved that the Town of Beaver pay for the purchase of a new door and new locks for the Fire Station/Community Building. Motion seconded by Alderman Benge; motion carried unanimously.

Betty Jean Baldridge, Fire Department Treasurer, stated that the Auxiliary possibly could pay for a security system.

The Mayor announced that due to the July meeting falling on the 4th of July and that many of the Council members will be away for the holiday, and also that there are no pressing issues, the July regular meeting will be cancelled. The council unanimously agreed.

The next council meeting will be August 1, 1987 at 2:00 P.M.

Mayor Ratliff called the meeting to order and four aldermen answered Roll Call: Reitz, Dorn, Benge and Rutter. Absent: Baldridge. A quorum was present.

Minutes of the June meeting were read and approved.

CORRESPONDENCE: The Mayor read letters from Gov. Clinton, Senator Pryor and Congressman Hammerschmidt regarding the railroad bridge. He also reported that he had received a call from Senator Bumpers.

Mayor Ratliff also read a letter he had written to Mr. Bill Debusk of the Corps of Engineers in reference to the railroad bridge.

COMMITTEE REPORTS: Ed Reitz, Chairman of the Zoning and Planning Committee reported no changes.

Park Chairman, Jim fitzsimmons, requested the Council approve a trailer for the Park mower. Alderman Reitz moved that the town purchase a trailer for the Park. Motion seconded by Alderman Rutter.
