- 3. Stress on the Beaver Bridge which has been the concern of all
- 4. Beaver council owes loyalty to Beaver residents, who elected them to serve the best interest of the people.
- 5. Although the area in question is across the bridge it is still in the Town limits, therefore, permission of Beaver is still needed.
- 6. Council already has voted NOT to SUBLEASE.



After much discussion from all in attendance, final decision was to permit Dickson to enter Table Rock Lake across (SE) and to the right of the Beaver bridge, (the ares built by the Highway Dept for repairing the bridge) This permit is pending permission from the State Highway DEpt.

The 1993 Budget was discussed and will be reviewed for approval at the January meeting.


