Others present were Bill Hill, and CCN reporter Kathryn Lucariello.

Jay Baldridge motioned seconded by Rick Pennington, to accept the Minutes of the November meeting as written. Vote to accept was unanimous.

Ann Shoffitt motioned, seconded by Jay Baldridge, to accept the financial statement as presented. Vote was unanimous.

FEMA update: Mayor presented amounts received from FEMA and suggested the Town use the \$2483.70 and supplement with funds from the Street Fund account to fill potholes in the Town and the Park. Disscussion followed. Ann Shoffit motioned, seconded by Jay Baldridge, to supplement allocated FEMA funds with street funds as neccessary to repair the roads and potholes in Park and within Town of Beaver. Vote was unanimous.

Jay Baldridge motioned, seconded by Ann Shoffitt, to hire a contractor to do repairs in Park to the buildings as written in the statement of work. Vote to accept was unanimous.

Jay Baldridge motioned, seconded by Rick Pennington, to table further discussion of Park business to the February meeting. Vote was unanimous.

In other business the Council reviewed the proposed 2012 budget, plugged in figures where needed. Ann Shoffitt motioned, seconded by Jay Baldridge, to re-address the 2012 budget with new figures plugged into place at the February meeting. Vote was unanimous.

TOWN OF BEAVER MINUTES March 12, 2012

The Mayor called the meeting to order at 7 p.m. and all present recited the Pledge of Allegiance.

The following answered Roll Call: Mayor Mary Hill, Council Members: Ann Shoffitt, Jay Baldridge, and Debbie Lester. Rick Pennington was absent and one seat remains vacant as well as the Recorder/Treasurer.

Others present were Beaver residents Chris Lester, Bill Hill and Tom Sterling.

Ann Shoffitt motioned seconded by Debbie Lester, to accept the Minutes of the January meeting as written. Vote to accept was unanimous.

Jay Baldridge motioned seconded by Debbie Lester to accept the financial statement as presented. Vote was unanimous.

Ann Shoffitt motioned seconded by Debbie Lester to approve the 2012 Budget as corrected at the January meeting. Vote was unanimous.

FEMA update: Mayor Hill reported that the town has received a total of \$48,638 from FEMA and that \$25,154 has been spent on the clean up and repairs at the Park. She recommended that the Town purchase a tractor to complete the clean up of the swimming area paved area and the boat launch paved area instead of hiring a contractor. This would enable the Town to continue to clean up as needed and also would be able to clean town streets if we get snow. The tractor will be stored in the 3rd bay of the firehouse when not in use at the Park.

Debbie Lester motioned seconded by Ann Shoffitt to purchase a Kubota tractor, L3200 series with front end loader for a quoted price of \$16,777. Jay Baldridge will negotiate the purchase. Vote was unanimous.

Ann Shoffitt motioned seconded by Debbie Lester to establish March 17th as Beaver Clean Up Day. Vote was unanimous. Clean up will start at 0800 and end at noon with a picnic provided by the Council.

Ann Shoffitt motioned seconded by Debbie Lester to rent a 30 foot roll off dumpster for the Spring Clean Up. Vote was unanimous.

Ann Shoffitt motioned seconded by Jay Baldridge to hire an electrician to install a 220 line so that the gardeners can pump water from the Lake to water the roses when needed. Vote was unanimous. (Note: Council had obtained permission from the Corps to pump water when the pump was donated to the Town several years ago)

In other business the Council asked Chris Lester to meet with the Park Committee and determine rates for this camping year and to look for a vehicle to replace the golf cart whose maintenance costs are exceeding current value.

Debbie Lester motioned that the Council adjourn at 8 pm, seconded by Jay Baldridge. Vote to adjourn was unanimous. Next meeting, April 9, 2012.
